General Information

- All documents must be <u>unaltered certified originals</u>, <u>certified amended originals</u>, <u>or true copies certified by the issuing agency</u>. Photocopies, notarized documents and online printouts are not accepted.
- If you are transferring driving privilege, you must also provide your driver license (valid or expired less than one year) or a motor vehicle report from your previous state/U.S. territory (dated within 30 days and showing a license that is valid or expired less than one year).
- Temporarily legal residents will receive a document bearing the phrase: "Not valid for federal identification, voting, or public benefit purposes."

Documents must verify through the USCIS SAVE verification system. Individuals with an immigration status of B-1, B-2, WB, WT, CP, or NC are not eligible for a Colorado document.				
Individuals with an expired USCIS document <u>may</u> be eligible for issuance if an appropriate I-797 Notice of Action is presented and verifies through SAVE.
